

WHEREAS, during the 2022 Regular Session of the Alabama Legislature, Act 2022-421 was enacted and codified in § 36-25A-5.2, Code of Alabama 1975, to authorize a county commission to allow a member who is physically absent due to illness to participate electronically in a meeting of the county commission, provided that a quorum of members are physically present at the meeting location; and

WHEREAS, the Cullman County Commission believes it is in the public's interest to allow members of the County Commission who are ill to participate electronically in meetings when a quorum is physically present as authorized by this new law; and

WHEREAS, the new law requires a county commission to adopt an Electronic Meetings Policy at least 45 days before the first meeting at which the electronic means of communication is used; and

WHEREAS, the new law requires the Electronic Meetings Policy to detail the communications equipment and procedures to be used, how the public may access the meeting, and how voting will be conducted; and

WHEREAS, based upon the foregoing, the <u>Cullman</u> County Commission has developed an Electronic Meetings Policy, which is attached to this resolution;

THEREFORE BE IT RESOLVED BY THE <u>CULLMAN</u> COUNTY COMMISSION that it does hereby authorize members who are absent due to illness to participate electronically in meetings of the County Commission pursuant to Act 2022-421 and the attached Electronic Meetings Policy.

BE IT FURTHER RESOLVED that copies of this resolution and the attached Electronic Meetings Policy be posted in a conspicuous location in the courthouse, published on the County Commission's website, and forwarded to all local news media who have on file with the County Commission a written request for notification of the schedule of regular meetings of the County Commission.

## **Electronic Meetings Policy**

#### I. Scope of Rules.

- A. Pursuant to Ala. Code § 36-25A-5.2, the following Electronic Meetings Policy was duly adopted by the <a href="Cullman">Cullman</a> County Commission on the <a href="20th">20th</a> day of <a href="December">December</a> 2022, and shall govern the conduct of the meetings of the County Commission beginning no sooner than 45 days after adoption.
- B. This Electronic Meetings Policy may be amended by affirmative vote of a majority of the members of the Commission. However, such changes to the Electronic Meetings Policy shall not take effect for at least 45 days after the vote making such changes.
- C. This Electronic Meetings Policy shall be read in conjunction with the County Commission's other policies pertaining to the Alabama Open Meetings Act, Ala. Code § 36-25A-5.

#### | Communications Equipment and Procedures.

- A. **Communications Equipment.** "Communications equipment" means any tools, devices, hardware, software, or other things necessary to facilitate communication among meeting participants who are in different physical locations and that allows all participants to hear one another at the same time. To allow a member who is ill to participate electronically in a meeting, the County Commission will use:
  - A conference phone with a dial-in number, microphone(s), a set of speakers, and any other necessary teleconferencing communications equipment. The member who is ill will receive the dial-in number in advance to facilitate his or her participation in the meeting. At the physical meeting location, there will be (1) a microphone that allows members who are physically present at the meeting location to speak to the member who is participating electronically, and (2) a set of speakers that allows those who are physically present at the meeting location to hear the member who is participating electronically.
  - A computer or laptop utilizing video-conferencing software, microphone(s), a webcam, a set of speakers, and any other necessary video-conferencing equipment. The member who is ill will receive a dial-in number or web link in advance of the meeting to facilitate his or her participation in the meeting. To the extent possible, the webcam will be situated in the physical meeting location in such a way that the physically present members may be seen by the member who is participating remotely. A microphone will be set up to allow members who are physically present to speak to the member who is participating electronically.
- B. Member Unable to Be Physically Present Due to Illness. If a member of the County Commission is unable to be physically present at a meeting of the County Commission due to illness, and he or she wishes to participate electronically in the meeting, then the member shall provide written notice to the Chairman and the County Administrator at least four hours before the meeting. If the member who is unable to be physically present at the meeting is the Chairman, then the Chairman shall provide written notice to the County Administrator at least four hours before the meeting. An email is sufficient for written notice under this Electronic Meetings Policy.
- C. Quorum Required. A member who is unable to be physically present due to illness may only participate electronically in a meeting if a quorum of the County Commission is physically present at the meeting location.

- D. **Testing the Communications Equipment.** Immediately before the commencement of a meeting at which a member participates through electronic means, the communications equipment shall be tested to verify: (1) All participants will be able to hear one another at the same time, and (2) Interested members of the public who are present at the physical meeting location will be able to hear those who are participating electronically in the meeting.
- E. Participation by Electronic Means. Consistent with Ala. Code § 36-25A-5.2, participation by electronic means shall constitute presence in person at the meeting for all purposes, except for the establishment of a quorum.
- F. Roll Call Voting. Any vote taken at a meeting utilizing the communications equipment described in this Electronic Meetings Policy shall be taken as a roll call vote that allows each member to vote individually in a manner audible to all persons participating or present.
- G. **Recordkeeping.** Documentation of the member's request to participate electronically due to illness shall be kept by the County Commission for recordkeeping purposes. Additionally, the following information shall be noted in the meeting minutes for a meeting in which there is participation by electronic means:
  - i. The communications equipment was tested immediately before the meeting for sufficient compliance with these requirements: (1) All participants will be able to hear one another at the same time, and (2) Interested members of the public who are present at the physical meeting location will be able to hear those who are participating electronically in the meeting.
  - ii. The names of the members who were physically present at the meeting location.
  - iii. Whether a quorum of members was physically present at the meeting location.
  - iv. The names of the member or members who participated electronically in the meeting due to illness and that the member or members who participated electronically were absent due to illness.
- H. **Expense Reimbursement.** A member participating electronically in a meeting may not claim any form of reimbursement for expenses related to that meeting, including mileage.

#### III. Public Access.

- A. **Meetings Open to the Public.** All regular meetings of the County Commission shall be open to the public as required by the Alabama Open Meetings Act.
- B. Accessibility. All regular meetings of the County Commission will be conducted in a building that is open to the public. At this physical location of the meeting, all members of the public shall be able to hear all persons who are participating electronically in the meeting.

# STATE OF ALABAMA LOW-INCOME HOUSEHOLD WATER ASSISTANCE PROGRAM (LIHWAP) VENDOR AGREEMENT

The undersigned (hereinafter referred to as the Vendor) hereby agrees to the following terms and conditions of the Alabama Department of Economic and Community Affairs (hereinafter referred to as the Department) in order to participate in the LOW-INCOME HOUSEHOLD WATER ASSISTANCE PROGRAM (LIHWAP) for the period of November 1, 2021 through September 30, 2023.

- (1) The Department, through its local administering LIHWAP agencies, shall notify the Vendor of each eligible household and the amount of assistance to be paid on behalf of the household.
- The Vendor agrees that any payment amount made by the Department or its administering LIHWAP agencies, and accepted by the Vendor, shall result in the continuation of service or the prompt and timely restoration of service for a period of not less than thirty (30) days from the date the Vendor receives official notification from the local administering LIHWAP agency of the payment. Notification shall include, but may not be limited to, the receipt by the Vendor of the Vendor's copy of the LIHWAP-101 application form and shall constitute a commitment on the part of the local administering LIHWAP agency for the payment of the home drinking water and/or wastewater services provided.
- (3) The Vendor agrees to charge LIHWAP eligible households the same price charged for home drinking water and/or wastewater services billed to non-eligible households.
- (4) The Vendor agrees to charge the eligible household, in accordance with the Vendor's normal billing process, the difference between the actual cost of home drinking water and/or wastewater services and the amount of the LIHWAP payment.
- (5) The Vendor agrees to provide the Department or its administering LIHWAP agencies with at least one designated contact person who shall be available to respond by telephone and electronic mail to all reasonable inquiries regarding LIHWAP household accounts, including but not limited to bills, payments, and services.
- (6) The Vendor agrees to post all payments to customer accounts within 3-5 business days.
- (7) The Vendor agrees not to apply LIHWAP payments to account balances that have previously been writtenoff or fully paid with other funds.
- (8) The Vendor agrees not to apply LIHWAP payments to commercial accounts. LIHWAP payments must only be applied to residential accounts.
- (9) The Vendor agrees not to discriminate against an eligible household with respect to terms, deferred payment plans, credit, conditions of sale, or discounts offered to other customers.
- (10) The Vendor agrees to provide the Department or its administering LIHWAP agencies, upon request, written reconciliation and confirmation that benefits have been credited appropriately to households and their services have been restored on a timely basis or disconnection status has been removed, if applicable.
- (11) The Vendor agrees to refund to the local LIHWAP administering agency any remaining LIHWAP balance when the household's account is closed. The Vendor shall include the household's account name and account number for reference purposes.
- (12) The Vendor agrees to cooperate with the Department's monitoring of this Agreement, including home drinking water and/or wastewater services provided to eligible households.

- If requested by the Department, the Vendor agrees to provide account data including, but not limited to, annual home drinking water and/or wastewater costs, bill payment history, and/or arrearage history for no more than the previous twelve (12) monthly billing periods, as authorized by the household.
- b. The Vendor agrees to cooperate with any Federal, State, or local investigation, audit, or program review. The Vendor shall allow Department representatives access to all books and records relating to LIWHAP households for the purpose of compliance verification with this Agreement.
- c. The Vendor understands that failure to cooperate with any Federal, State, or local investigation, audit, or program review may result in the immediate disqualification from participation in the LIHWAP.

The Vendor shall observe its usual and customary practices governing the release of household account information.

- (13) The Vendor and the Department agree that any information and data obtained as to personal facts and circumstances related to households shall be collected and held confidential, during and following the term of this Agreement, and shall not be disclosed without the individual's and Department's written consent and only in accordance with federal or state law. Companies who utilize, access, or store personally identifiable information as part of the performance of this Agreement are required to safeguard this information and immediately notify the Department of any breach or suspected breach in the security of such information. The Vendor shall allow the Department to both participate in the investigation of incidents and exercise control over decisions regarding external reporting.
- (14) The Vendor will be permanently disqualified from participating in the LIHWAP upon the first finding of LIHWAP fraud. Fraud includes, but is not limited to, intentionally providing false information to the local administering LIHWAP agency or knowingly allowing others to do so; intentional failure to notify the local administering LIHWAP agency of a change in circumstances that affects payments received by the Vendor; intentionally accepting payments that the Vendor knows, or by reasonable diligence would know, the Vendor is not entitled to by virtue of an overpayment or otherwise; or intentionally making a claim for a payment to which the Vendor is not entitled pursuant to the terms of this Agreement and all applicable rules, regulations, laws and statutes. Repayment must be made unless contrary to a court order.
- (15) This Agreement will terminate effective immediately upon determination by the Department that the Vendor is not in compliance with the terms of this Agreement. The Vendor will be notified within 15 calendar days of the termination. Either the Department or the Vendor may terminate this Agreement with or without cause and without cost by giving the other party at least 60 calendar days written notice. Termination by either party shall not discharge any obligation owed by either party on behalf of the household that has been awarded the benefit.
- (16) The Vendor agrees to not discriminate based on race, color, religion, sex, age, national origin, or disability in its implementation of this Agreement.
- (17) The Vendor agrees that the terms and commitments contained herein shall not be constituted as a debt of the State of Alabama in violation of Article 11, Section 213 of the Constitution of Alabama, 1901, as amended, by Amendment No. 26. The Vendor further agrees that if any provision of this Agreement shall contravene any statute or Constitutional provision or amendment, either now in effect or which may, during the course of this Agreement, be enacted, then that conflicting provision in the Agreement shall be deemed null and void.

The Vendor recognizes and acknowledges that the Department is an instrumentality of the State of Alabama, and as such, is immune from suit pursuant to Article 1, Section 14, Constitution of Alabama 1901. It is further acknowledged and agreed that none of the provisions and conditions of this Agreement shall be deemed to be or construed to be a waiver by the Department of such Constitutional Immunity.

In the event of any dispute between the parties, senior officials of both parties shall meet and engage in a good faith attempt to resolve the dispute. Should that effort fail, and the dispute involves the payment of money, a party's sole remedy is the filing of a claim with the Board of Adjustment of the State of Alabama.

For any and all disputes arising under the terms of this Agreement which are not resolved by negotiation, the parties agree to utilize appropriate forms of non-binding alternative dispute resolution including, but not limited to, mediation. Such dispute resolution shall occur in Montgomery, Alabama, utilizing where appropriate, mediators selected from the roster of mediators maintained by the Center for Dispute Resolution of the Alabama State Bar.

By signing this Agreement, the contracting parties affirm, for the duration of the Agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama. Furthermore, a contracting party found to be in violation of

this provision shall be deemed in breach of the Agreement and shall be responsible for all damages resulting therefrom.



Contractor does not provide engineering, consisting or architectural services. It is the Owner's responsibility to retain a licensed architect or engineer to determine proper design and code compliance. If plans, specifications or other design documents have been furnished to Contractor, Customer warrants that they are sufficient and conform to all applicable haves and building codes. Contractor is not responsible for loss, damage or expense due to defects in plans or specifications or building code violations unless such damage results from a deviation by Contractor from the contract documents. Contractor is not responsible for location of rood drains, adequacy of drainges, conding on the roof or structural conditions.

2. Commencement of Work. Customer warrants that the structures on which Contractor is to work are in sound condition and capable of withstanding normal activities of roofing construction, equipment and operations. Contractor's prosecution of the roof work indicates only that the surface of the deck appears satisfactory to Contractor to attach roofing materials. Contractor is not responsible for the construction, undulations or structural sufficiency of the roof deck or other trades' work or design.

3. Asbestos and Toxic Materials. This proposal is based on Contractor's not coming into contact with asbestos-containing or toxic materials. Contractor is not responsible for expenses, claims or damages arising out of the presence, disturbance or removal of asbestos-containing or toxic materials. Contractor shall be entitled to reasonable compensation for all additional expenses incurred as a result of the presence of asbestos-containing or toxic materials at the work site. Customer agrees to indemnify Contractor from and against any liability, damages, losses, claims, demands or citations arising out of the presence of asbestos or toxic materials at the work site.

4. Payment. Unless stated otherwise on the face of this proposal, Customer shall pay the contract price

Unless stated otherwise on the face of this proposal, Customer shall pay the contract price plus any additional charges for changed or extra work within ten (10) days of substantial completion of the Work. If completion of the Work extends beyond one month, Customer shall make monthly progress payments to Contractor by or before the fifth (5th) day of each month for the value of Work completed during the preceding month, plus the value of materials suitably stored for the project. All sums not paid when due shall earn interest at the rate of 1-1/2% per month. Contractor shall be entitled to recover from Customer costs of collection, including attorney's fees, resulting from Customer's failure to make proper payment when due. Contractor's entitlement to payment is not dependent upon criteria promulgated by Factory Mutual Global, including wind uplift testing.

5. Right to Stop Work. The failure of Customer to make proper payment to Contractor when due shall, in addition to all other rights, constitute a material breach of contract and shall entitle Contractor, at its discretion, to suspend all work and shipments, including furnishing warranty, until full payment is made. The time period in which Contractor shall perform the work shall be extended for a period equal to the period during which the Work was suspended, and the contract sum to be paid Contractor shall be increased by the amount of Contractor's reasonable costs of shut-down, delay and start-up.

6. Insurance, Contractor shall carry worker's compensation, automobile and commercial general liability insurance. Customer agrees to remove or protect property directly below the roof in order to minimize potential interior damage. Contractor shall not be responsible for disturbance, damage, clean up or loss to Interior property that Customer did not remove or p prior to commencement of roofing operations. Customer shall notify tenants of re-roofing and the need to provide protection underneath areas being re-roofed. Customer agrees to hold Contractor harmless from claims of tenants who were not so notified and did not provide protection.

9. Damages and Delays. Contractor will not be responsible for damage done to Contractor's Work by others. Any repairing of the same by Contractor will be charged as an extra. Contractor shall not be liable for liquidated or delay damages due to a delay in completion of the Project unless the delay was caused by Contractor. SUBJECT:

Protecting Alabama from Chinese Infiltration by Prohibiting the Use of TikTok

on State IT Infrastructure

Protecting Alabama's IT infrastructure from cyber threats is vital to ensuring the safety and success of our State. The computer devices and networks used by our state government house significant amounts of Alabamians' sensitive data. They also ensure the proper functioning of numerous automated government functions.

Recently, national security officials have warned of growing threats posed by the video-sharing app TikTok. TikTok is owned by a Chinese parent company and thus potentially subject to Chinese laws enabling its data to be shared with the Chinese Communist Party.

Disturbingly, TikTok harvests vast amounts of data from its users, much of which has no legitimate connection to the app's supposed purpose of video sharing. For example, when users run the TikTok app for the first time, they give TikTok access to information such as their device brand and model, mobile carrier, browsing history, app and file names and types, keystroke patterns and rhythms, wireless connections, and geolocation. Use of TikTok involving state IT infrastructure thus creates an unacceptable vulnerability to Chinese infiltration operations.

Given these serious security concerns related to the use of TikTok, I have asked the Secretary of Information Technology to update his agency's policies to prevent TikTok from accessing the state IT network and state IT devices—even while providing exceptions for law enforcement and other essential governmental uses of the app.

These new policies accompany this memorandum. Consistent with these policies, executive branch agencies should immediately take all necessary steps to prevent TikTok from accessing sensitive state data.

Thank you for all you do to ensure the success and safety of our great State. Together, we will defend the State of Alabama and its people from the growing security risk posed by TikTok.
