CULLMAN COUNTY COMMISSION MEETING October 23, 2012

CALL TO ORDER AND WELCOME

Chairman James Graves called the Commission Meeting to order at 10:03 a.m. and welcomed the visitors.

CALL OF ROLL TO ESTABLISH QUORUM, INVOCATION AND PLEDGE OF ALLEGIANCE

The County Clerk called the roll; present were Chairman James Graves, Commissioner Darrell Hicks, Commissioner Stanley Yarbrough and County Attorney Heath Meherg. The invocation was given by Darrell Hicks. Randall Shedd led the Pledge of Allegiance.

<u>APPROVE MINUTES OF THE OCTOBER 9, 2012 MEETING, APPROVE APPROPRIATIONS, EXPENDITURES, REQUISITIONS, TRAVEL EXPENSES; AND APPROVE ALL JOURNAL ENTRIES TO BE POSTED.</u>

Commissioner Yarbrough made the motion to approve the minutes from the October 9, 2012 Commission Meeting, approve appropriations, expenditures, requisitions, travel expenses and approve all journal entries to be posted. Commissioner Hicks seconded the motion which passed on a unanimous voice vote.

NEW BUSINESS

Designate bank depositories for County funds

Gary Teichmiller, County Administrator, stated the County must designate annually the banks where deposits can be held. He recommended the Commission authorize any local bank that is in the SAFE program be used as a depository for County funds. Commissioner Yarbrough made a motion to designate all local banks in the SAFE program for deposits. Commissioner Hicks seconded. The motion passed on a unanimous voice vote.

Consider approval of Memorandum of Settlement with Decatur General for payment of \$1,100

Heath Meherg, County Attorney, stated the settlement with Decatur General would avoid any further litigation and the County will be asking for a dismissal. Commissioner Yarbrough made a motion to approve the memorandum of settlement with Decatur General and issue payment of \$1,100 in the settlement. Commissioner Hicks seconded. Upon a unanimous voice vote, the motion passed.

Authorize the Chairman and EMA Director to sign the SMORT grant for FY 2012 for training and supplies in the amount of \$9,903

Phyllis Little, EMA Director, stated the FY 2012 State Mortuary Operations Response Team (SMORT) grant allocates \$8,000 for supplies and equipment and \$1,900 for training in Region 6. Commissioner Hicks made a motion to authorize the signing of the grant. Commissioner Yarbrough seconded. The motion carried on a unanimous voice vote.

Consider awarding the contract for renovations to the bathroom at Sportsman Lake Park to Good Hope Painting & Contracting –Total \$28,862.00

Chairman Graves explained this contract will complete the renovations of all the restrooms and bath houses at Sportsman Lake. Part of the cost will be covered by at \$15,000 grant from the Cullman County Community Development Commission (CCCDC). Commissioner Yarbrough made a motion to award the renovation contract to Good Hope Painting & Contracting. Commissioner Hicks seconded the motion which passed on a unanimous voice.

Resolution 2013-05 - Sales Tax Holiday for Severe Weather Preparedness

Chris King, Director of Sales Tax, stated the tax free period will be the last weekend in February. This resolution includes Cullman County's participation in subsequent years unless the County notifies the State Revenue Department otherwise at least fourteen (14) days prior to the event. Commissioner Yarbrough made a motion to adopt the resolution for Cullman County's participation is the sales tax holiday for severe weather preparedness. Commission Hicks seconded the motion which passed on a unanimous voice vote.

Resolution 2013-06 - Logging Notice - Replaces Resolution 2012-39 Revised adopted 8-30-2012

Jon Brunner, County Engineer, stated the new resolution includes language suggested by the ACCA regulating logging notices and permitting. It does not change any of the policies currently being used by the County. Commissioner Yarbrough made a motion to adopt the resolution concerning logging. Commissioner Hicks seconded. The motion passed on a unanimous voice vote.

Resolution 2013-07 – Application for Airport Improvement Project

David Parker with Goodwin Mills & Cawood informed the Commission this is the request the airport makes annually to the FAA for funding. The application is for FY-2013. Commissioner Yarbrough made a motion to approve the application to the FAA for funding for airport improvements. Commissioner Hicks seconded the motion which passed on a unanimous voice vote.

Bid No. 1118 - Two (2) or more 25 cu/yd Rear-loading Refuse Trucks

James Rollo, Sanitation Manager, stated the low bidder was Neely Coble Company at \$145,402. He recommended awarding the bid. Commissioner Hicks made a motion to award the bid for two (2) or more 25 yd³ rear-loading refuse trucks. Commissioner Yarbrough seconded the motion. Upon a unanimous voice vote, the motion carried.

Bid No. 1119 – Two (2) or more 6 cu/yd Side-loading Refuse Trucks

Mr. Rollo stated Neely Coble Company was also the low bidder, at \$93,826, for two (2) or more 6 yd³ side-loading refuse trucks. Commissioner Yarbrough made a motion to award the bid to Neely Coble Company. Commissioner Hicks seconded. The motion passed on a unanimous voice vote.
