CULLMAN COUNTY COMMISSION MEETING November 27, 2012

CALL TO ORDER AND WELCOME

Chairman Kenneth Walker called the Commission Meeting to order at 10:03 a.m. and welcomed the visitors.

CALL OF ROLL TO ESTABLISH QUORUM

The County Clerk called the roll; present were Chairman Kenneth Walker, Commissioner Darrell Hicks, Commissioner Stanley Yarbrough and County Attorney Heath Meherg. The invocation was given by Buchanan Jackson. Billy Coleman led the Pledge of Allegiance.

APPROVE MINUTES OF THE NOVEMBER 14, 2012 MEETING, APPROVE APPROPRIATIONS, EXPENDITURES, REQUISITIONS, TRAVEL EXPENSES; AND APPROVE ALL JOURNAL ENTRIES TO BE POSTED.

Commissioner Yarbrough made the motion to approve the minutes from the November 14, 2012 Commission Meeting, approve appropriations, expenditures, requisitions, travel expenses and approve all journal entries to be posted. Commissioner Hicks seconded the motion which passed on a unanimous voice vote.

Phyllis Little, EMA Director, stated the County has participated in mutual aid agreements with other counties since the late 1970's and these are updated every five to seven years. There are currently 15 counties and a number of municipalities who have agreed to assist one another in times of natural disaster or other hardships. Commissioner Yarbrough made a motion to authorize the signing of the North Alabama Mutual Aid Agreement. Commissioner Hicks seconded the motion which passed on a unanimous voice vote.

Commission to accept the transfer of an enclosed utility trailer donated from the Fairview Town Council for exclusive use by the Cullman County Commission on Aging – 2012 Homesteader, Inc. Trailer, model 612PS, VIN# 5HABE1214CN018163 valued at \$2,500

Commissioner Hicks made a motion to accept the donation from the Fairview Town Council of a 2012 Homesteader trailer for use at the Commission on Aging. Commissioner Yarbrough seconded the motion. Upon a unanimous voice vote, the motion carried.

It is a pledge the allocated one-half cent sales tax will continue to be paid to the City School System for the duration of the bonds which are scheduled to be retired March 1, 2042. Commissioner Hicks made a motion for adoption of the resolution concerning the levy and collection of the countywide school sales tax. Commissioner Yarbrough seconded. The motion passed on a unanimous voice vote.

Dr. Jan Harris, Superintendent of Education for the Cullman City School, thanked the commission for their support of education in Cullman County. Mr. Billy Coleman, County Superintendent of Education, also thanked the Commission and stated the County and City School system will continue to work together and support education in Cullman County.
