Oversees the work of contractors to ensure tasks are completed and standards are met. Other duties may be assigned.	
REQUIREMENTS FOR POSITION	<ul style="list-style-type: none"><li>• Must have valid Alabama driver's license and an acceptable driving record that meets the County insurance carrier's standards for coverage.</li><li>• Must have knowledge of public building maintenance and repair.</li><li>• Must have the ability to troubleshoot general building system problems.</li><li>• Must have knowledge of basic air conditioning, plumbing and electrical repair.</li><li>• Must have the ability to communicate effectively with co-workers, elected officials, vendors and the general public in person and over the phone.</li><li>• Must have the ability to be on call for emergency maintenance calls.</li><li>• Must be able to work weekends and holidays if required.</li></ul> <p>This is a "safety-sensitive" position.
