CULLMAN COUNTY COMMISSION MEETING MINUTES January 10, 2023

CALL TO ORDER AND WELCOME GUESTS

Chairman Clemons called the Meeting at 6:00 p.m.

CALL OF ROLL TO ESTABLISH QUORUM

Tiffany Merriman, County Clerk, called roll; present were Chairman Jeff Clemons, Commissioner Kerry Watson, Commissioner Garry Marchman, Commissioner Kelly Duke, Commissioner Corey Freeman, County Administrator John Bullard, County Attorney Emily Johnston, and County Engineer Bryan Cheatwood. Trae Norrell gave the invocation. Facilities and Equipment Manager Shane Bailey led the Pledge of Allegiance.

APPROVE THE MINUTES OF THE DECEMBER 20, 2022, MEETING, APPROPRIATIONS, EXPENDITURES, PERSONNEL ACTIONS, PAYROLL, AND REQUISITIONS, AND APPROVE ALL JOURNAL ENTRIES TO BE POSTED

Commissioner Watson made a motion to approve the minutes of the December 20, 2022, meeting, appropriations, expenditures, personnel actions, payroll, and requisitions, and approve all journal entries to be posted. Commissioner Marchman seconded, and the motion passed on a unanimous voice vote.

PUBLIC COMMENTS/UPDATES

Chairman Clemons announced that we had no request for public comments or updates submitted by the agenda deadline.

NEW BUSINESS

Recognition: Jeff Preston retiring after 25 years of service with the Road Department

Commissioner Watson made a motion to Recognition: Jeff Preston retiring after 25 years of service with the Road Department. Commissioner Duke seconded. The motion passed on a unanimous voice vote.

Resolution 2023-10: Enter into contract with Goodwyn, Mills, & Cawood for the Cullman Regional Airport Terminal Apron Rehabilitation and authorize Chairman to sign all related paperwork

Airport Manager Ben Harrison addressed the Commission and stated this is the AIP Grant for the fiscal year 2023 and AIP is airport improvement program. This grant total anticipated funding of this grant is \$256,500 which is FAA dollars, \$14,250 is ALDOT dollars, and \$14,250 would be our portion split between the County and the City which would make it \$7,125 each. This is to rehab the concrete apron in front of the terminal building.

Commissioner Watson made a motion to approve Resolution 2023-10: Enter into contract with Goodwyn, Mills, & Cawood for the Cullman Regional Airport Terminal Apron Rehabilitation and authorize Chairman to sign all related paperwork. Commissioner Marchman seconded, and the motion passed on a unanimous voice vote.

Resolution 2023-11- Submit Rebuild Alabama Grant Application for County Road 1282

Project Coordinator Matt Kinsland stated this is the annual Rebuild Alabama Grant, it is \$250,000 and there is not match requirement on this grant. This resolution would authorize the Chairman to sign the documents pertaining to this grant and allow us to submit the grant.

Commissioner Freeman made a motion to approve Resolution 2023-11- Submit Rebuild Alabama Grant Application for County Road 1282. Commissioner Duke seconded. The motion passed on a unanimous voice vote.

Authorize increase of \$687.20 for upgraded door access control system from ADS for a total of \$28,526.63 over previous amount approved

County Administrator John Bullard addressed the Commission and stated they had to add a couple of more units to swipe the key cards that were not anticipated, but it was only \$687.20 more than what was approved in the last meeting.

Commissioner Marchman made a motion to approve increase of \$687.20 for upgraded door access control system from ADS for a total of \$28,526.63 over previous amount approved. Commissioner Watson seconded, and the motion passed on a unanimous voice vote.

Authorize Chairman to sign contract with Loomis Bros Circus to perform at the Ag Center February 3^{rd,} 2023 - February 5th, 2023

Parks Director Doug Davenport stated this is the same circus that we have had for the last nine years. Commissioner Duke made a motion to approve to Authorize Chairman to sign contract with Loomis Bros Circus to perform at the Ag Center February 3^{rd,} 2023 - February 5th, 2023. Commissioner Freeman seconded. The motion passed on a unanimous voice vote.

Authorize Chairman to sign the Alabama Department of Youth Services Agency Grant Agreement for Fiscal Year 2021-2022 (Partial Year July-September 2022) in the amount of \$153,888 as the fiscal agent for Lauderdale County

Juvenile Director Kay Bell stated this is just a partial year, you have already approved 2022-2023. This is a partial year they changed programs.

Commissioner Freeman made a motion to approve the Chairman to sign the Alabama Department of Youth Services Agency Grant Agreement for Fiscal Year 2021-2022 (Partial Year July-September 2022) in the amount of \$153,888 as the fiscal agent for Lauderdale County. Commissioner Marchman seconded, and the motion passed on a unanimous voice vote.

Authorize payment of invoice for previously approved amount of \$477,837 to EMC directly for Property and Casualty Insurance through Byars Wright

County Administrator John Bullard addressed the Commission and stated that this is a clarification. It was previously approved for the same amount for property and casualty insurance through Byars Wright but the invoice is directly from EMC and just for audit purposes, we wanted to make sure we had that clarification.

Commissioner Duke made a motion to approve payment of invoice for previously approved amount of \$477,837 to EMC directly for Property and Casualty Insurance through Byars Wright. Commissioner Watson seconded. The motion passed on a unanimous voice vote.

Consider increasing the monthly payments for the lease storage units at Smith Lake Park to \$280

Parks Director Doug Davenport stated right now we are charging \$240 for the cost of electricity and everything. We have been checking around with other parks on their prices. It is our recommendation to increase from \$240 to \$280 and that will not take place until their lease runs out.

Commissioner Freeman made a motion to approve increasing the monthly payments for the lease storage units at Smith Lake Park to \$280. Commissioner Duke seconded, and the motion passed on a unanimous voice vote.

County Engineer Bryan Cheatwood addressed the Commission and stated our staff has reviewed this preliminary plat and it does meet our subdivision requirements. I do recommend approval of this plat. Commissioner Marchman made a motion to approve the Proposed plat Serenity Pointe Cabins. A major subdivision containing 12 Lots located off County Road 338. Commissioner Freeman seconded. The motion passed on a unanimous voice vote.

Bid # 1384: Extension-Fireworks for July 4th Show at Smith Lake Park

Parks Director Doug Davenport addressed the Commission and stated we bid this last year with a two-year adoption with a two-year extension. It's our recommendation to extend another year with the same fireworks company.

Commissioner Duke made a motion to approve Bid # 1384: Extension-Fireworks for July 4th Show at Smith Lake Park. Commissioner Freeman seconded, and the motion passed on a unanimous voice vote.
